TG proposed that the site of the field beside the church not be considered as a preferred site IW seconded on the grounds that there would be highway issues and it had not been identified as a possible site from any parishioner via the parish questionnaire responses. All in favour.

Correspondence from DLP.

After a delayed response to our offer of a meeting, JG had received an email from Patrick Reed of DLP Planning Ltd (DLP) asking if the group could advise them as to the intentions of the group in reference to the development of the site adjacent to the playing field.

JG proposed DLP be given the option to participate in the data gathering exercise by way of email and that the questions asked of the other developers be emailed to them, the answers of which can be considered at the next meeting of the group. IW seconded all in favour
