3. To approve and sign the minutes of the Ordinary Meeting dated 4^{th} November 2014

Draft minutes had been circulated. The following amendments were proposed:

At the end of Section 6: Add "JFG asked why the Representatives' contact details were not yet on the noticeboard as agreed at the September meeting. It was noted that the Clerk was still awaiting agreement from one Parish Councillor.".

4. Open forum

5.1 Matters arising from previous meetings

5.1 Modification Order of The Loop, Staverton

JFG reported no progress.

5.2 Consideration of changing street lighting maintenance contractor and mercury street lighting

JFG reported that work had been completed on the light by the allotments, materials for repair of the light on Home Close are on order and repairs to streetlights 9 and 28 will be done.

STa arrived at the meeting.

Discussion then took place with regards to changing street lights.

Proposal: to agree that the next phase, providing funds are available, would be to replace 2 street lights in Braunston Lane during summer 2015 with DW Windsor 'Chester' columns with 'York' 70W SON lanterns.

Proposed by JFG, seconded by EK-B. All in favour. Carried.

5.3 Consideration of letting of Barn 2015/2016

The Clerk had been in contact with the current incumbent but had not yet had confirmation as to whether they wish to continue.

5.4 Report on mole catching

JFG was given authority to purchase more mole traps.

5.5 Consideration of playing field inspection report and outstanding repairs TG reported that it is an insurance requirement for an inspection to be carried out. The only repairs outstanding at the moment are low priority ones.

Proposal: To remove from the agenda. Proposed by TG, seconded by JFG. All in favour. Carried. 5.6 Consideration of quotes for written inspection on the beech tree on The Green The Clerk had not been contacted by Cutting Edge and the contract had been duly awarded to B Hatton who had advised that he will carry out the inspection in the new year.

5.7 Consideration of draft Planning Policy Statement

Although a group had met to discuss this matter, there were a number of blanks which need to be filled in. Therefore, the matter was deferred to the January meeting.

5.8 Consideration of draft policy regarding recording of Parish Council meetings and amendment to Communications Policy

Deferred to the January meeting. The Clerk will circulate a shorter draft showing tracked changes.

5.9 Consideration of Neighbourhood Plan

It was noted that examples of other Plans are available and that a small group should be set up to take the matter forward. Deferred to January for action.

5.10 Consideration of sewerage issue in Staverton notified to Severn Trent Water Ltd

The Clerk reported that she had written to Severn Trent (letter sent by post and email) but had had no response as yet. The Clerk will chase.

County Councillor Brown reported that NCC's budget meeting will be taking place next week at which there is a requirement to reduce the budget by £40 million. It was noted that, with regards to the new homes bonus, NCC receives 20% whilst DDC receives 80%. However, it is NCC which has responsibility for infrastructure.
